

## Best Authority® Licensing

This is an informal summary of Best Authority® Licensing. The exact terms of the license are contained in the Best Authority® End User License Agreement (EULA).

Best Authority is licensed as a permanent site license. There is **one license per organization**, based on the total number of litigators and appellate attorneys. This may include attorneys in departments other than litigation—such as labor, intellectual property, etc., and under certain circumstances, paralegals doing attorney-like work.

Best Authority is **not** licensed based on the number of PCs on which it is installed, nor on the number of users.

Once your organization has purchased the required license, Best Authority may be installed on any number of PCs, and run by any member of your firm or its staff. In addition, it may be used without charge for certain de minimis purposes (for example: if a paralegal is preparing a table of authorities for a class he or she is taking at law school, or a non-litigator attorney is filing an appeal pro bono.)

### ■ Purchasing for Additional Litigators

When an organization adds litigators, it will need to update its license. If the number of new litigators is less than 20% of the existing total, the customer can pay for the updated license at the same time they renew the SSS. If the number of new litigators is greater than 20% of the existing total, the customer will need to purchase an updated license at the time of the increase.
